# Centers for Medicare and Medicaid Services (CMS)

CMS is one of the largest departments under the Health and Human Services (HHS) agency. The CMS Administrator is nominated by the President and is a position that requires Senate confirmation. CMS oversees government health insurance programs covering more than one out of three Americans and is a vital foundation of the health care system. Under the CMS umbrella are centers for Medicare, Medicaid and Children's Health Insurance Program (CHIP) Services, Medicare and Medicaid Innovation (CMMI), and Clinical Standards and Quality.

If confirmed, Brooks-LaSure would be the first black woman to head the \$1 trillion agency, holding the second most powerful agency role, after the role of HHS Secretary.
